**Waiver, Release, Covenant Not to Sue and Indemnity Agreement  
(Adult and/or Minor Children)**

Each of the undersigned, for himself, his heirs, representatives, and successors, does hereby and forever absolutely waive and release any claim for damage or injury to the undersigned or their minor children which hereafter may arise or result from participation by the undersigned or the undersigned's minor children in any activity of the St. Vrain Roundup Club (SVRC), (an informal and unincorporated association), and does hereby covenant and agree not to sue the St. Vrain Roundup Club, or any of its members or agents, or any other person on whose premises the activities of the St. Vrain Roundup Club may be conducted, or any other person acting under the direction or control of such named parties, for any such claim.

The consideration for this waiver, release and covenant not to sue and indemnity agreement is the acceptance of the undersigned and their minor children for participation in the activities of the St. Vrain Roundup Club. It is acknowledged and agreed that such participation in any activities of the St. Vrain Roundup Club would be strictly forbidden absent the execution of this document by the undersigned.
